*The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.*

*First Central Presbyterian Church has put in place preventative measures for the Children's Ministry to reduce the spread of COVID-19 (screening and temperature taking of parents and children upon arrival, hand sanitizer stations, rules regarding close contact while at the event, and mask wearing); however, First Central Presbyterian Church cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending Children's Ministry events could increase your risk and your child(ren)'s risk of contracting COVID-19.*

*By submitting this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending any event and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at an event may result from the actions, omissions, or negligence of myself and others, including, but not limited to, program coaches, volunteers, other participants and their families.
